# BLOCKOUT BLUE POND DYE

## GENERAL INFORMATION

BLOCKOUT BLUE POND DYE is a flexible, concentrated formulation that is a non-toxic water colorant. BLOCKOUT BLUE POND DYE creates a beautiful natural appearance for your lake and pond. This product is an excellent complement to the already existing beauty of golf courses and park fountains. BLOCKOUT BLUE POND DYE is safe to fish and aquatic species, water fowl, wildlife and pets. It is a non-corrosive dye and when used according to recommended rates will not stain stone, fountains, approved aquatic features or swimwear. The dye will stain rocks, decking and other porous surfaces if spilled or applied as a concentrate.

## PRECAUTIONARY STATEMENTS

Do not use in water that is expected to be consumed by humans. BLOCKOUT BLUE POND DYE is safe for swimming after complete dispersal. Use BLOCKOUT BLUE POND DYE only in bodies of water that have restricted flow.

## APPLICATION OR USE RATES

BLOCKOUT BLUE POND DYE should be applied one (1) gallon of dye per acre of water with an average water depth of four (4) feet (4 acre-feet). One (1) ounce treats approximately (8,500) gallons of water for small ponds.

**An acre/foot of water can be determined using the following formula:**

$\text{Pond Length (ft.)} \times \text{Pond Width (ft.)} \times \text{Average Depth (ft.)} / 43,560 \text{ ft.} = \text{Acre/Foot of Water}$

## DIRECTIONS FOR USE

Pour the appropriate amount of dye into the water along the edge of the lake or pond. BLOCKOUT BLUE POND DYE will distribute evenly, dispersing with lake and pond currents, and wind-blown water movement. To assist diffusion throughout the entire lake or pond, empty the gallon container(s) at different points around the lake or pond edge, or through an aerator, circulation or injection system, waterfall or fountain. Wear eye protection and rubber gloves, carefully applying the dye directly to the water.

BLOCKOUT BLUE POND DYE is a high-quality, aquatic dye that will be degraded by chlorine, which will diminish the lake or pond coloration. In non-chlorinated systems or lakes and ponds, dye is broken down gradually through biological and photo-degradation. Coloration is also reduced through the natural process of dilution (i.e. - addition of fresh water to the lake or pond). The original color level should be stable for 2-4 weeks, depending on your lake or pond system.

Chlorinated systems typically require dye addition within 2 weeks, while biological and photo-degradation is common within 4 weeks.

To return your beautiful lake or pond color to its intended coloration level, simply add small amounts of BLOCKOUT BLUE POND DYE from time to time which will offset the natural color loss.

## STORAGE AND DISPOSAL

Store in cool, dry place. Keep in original container tightly closed. Freezing will not harm the product but the container presents a burst potential if frozen. Do not reuse empty container. Triple rinse and offer container for recycling or reconditioning, or puncture and dispose of in an approved waste disposal facility, or other procedures in accordance with federal, state and local regulations.
