GENERAL INFORMATION:

LIQUID CARBON PLUS is designed to aid in the breakdown of organic matter, feed your soil microbes and assist in improving moisture management in your soil. May aid in micronutrient availability.

DIRECTIONS FOR USE AND APPLICATION RATES:

- Shake container well before diluting
- Store product in a cool and dry place in original container
- Test compatibility with other products prior to use
- Mix 10 or more gallons of water with LIQUID CARBON PLUS application rates shown below prior to use

Aerial / Ground / Fertigation / Foliar: 2-4 quarts per acre.

Always conduct a soil test to evaluate nutrient levels to determine needed amendments to boost fertility levels in your soil. LIQUID CARBON PLUS is a supplement to your fertilizer program.

COMPATIBILITY

LIQUID CARBON PLUS is compatible with herbicides, fungicides, insecticides and fertilizers. If the desired combination has not previously been used, a compatibility test is recommended.

FIRST AID

Have the product container with you when going for treatment or calling a poison control center or doctor.
